Re: City of Whitehorse Application to the Surface Rights Board

The Yukon Surface Rights Board (the 'Board') is in receipt of your application respecting the City of Whitehorse and Rob Hamel and Norwest Enterprises Inc. However, the Board cannot accept your application as submitted.

The City has applied for an order of the Board under sections 42 and 43 of the *Yukon Surface Rights Board Act* (the '*Act*') to prevent Rob Hamel and Norwest Enterprises from accessing certain quartz mining claims until Hamel and Norwest provide security in the amount of \$1,000,000. Sections 42 and 43 of the *Act* address access orders that the Board may make for persons who have a right of access described in section 1 of Schedule II of the *Act*. All of these situations involve a right of access subject to the consent of a Yukon First Nation, or order of the Board, and apply to Settlement Land only. The Board does not believe that sections 42 and 43 apply to the issue raised by the City of the Whitehorse in its application and hence our rejection of the application as submitted.

I should also note for your future reference that as per the Yukon Surface Rights Board Rules of Procedure, an application must contain a record of negotiation efforts. Section 4 of the Rules describes the detail required in the record of negotiation. Proof of service respecting written notice to the other parties of the application would also be appreciated.
